### **RSPH UPDATES:**

#### Quantitative Essentials for Public Health

Once again, our incoming cohort will have access to the Quantitative Essentials for Public Health course site. This optional resource was designed to review quantitative knowledge and provide a refresher. The course is available for all RSPH students. Still, it is especially recommended for those students whose undergraduate education did not have a quantitative emphasis or those who have been out of school for several years in non-quantitative positions and need a refresher.

This course consists of three modules that cover the Ouantitative Essentials of Public Health:

- Module 1: Fractions, Decimals, and Percentages
- Module 2: Algebra
- Module 3: Essential Functions and Notation
